Dear Residents:

I would like to thank all of the residents who attended this year's Pig Roast. Our next event will be Breakfast with Santa for all our residents. This event is at no cost. Please check out the flyer in this Newsletter.

As the year winds down there are a few things on the drawing board. The first thing is the annexation on Rollins Road, Fairfield Road and Lake Shore Drive. This triangle piece will hopefully be a commercial Strip Mall in the near future. The second thing will be the final acceptance of both subdivisions; Pasquinelli and Neumann Homes are on their final punch list. Hopefully we will be able to finally build the park on Huron Hills Trail. We apologize this has taken so long but we are building this park as an after thought and not from the beginning. We need to accept Fox Glen subdivision and then dedicate that parcel of land to the Park District. We hope to accept both subdivisions by the end of the year.

The well station is a little behind schedule because of the bids coming in much higher then we anticipated, but we are thinking the project and shortly we will be going out to bid again. We are hoping that the project will be done by spring of 2006. We are just applying for CDBG 2006 Grant, which will total \$150,000.00 and we will be continuing to replace our water lines.

I hope that you are listening to our new Radio Station, WRLR 98.3, located in Round Lake Heights. Please support them by listening to them.

I would also like to invite you to our Texas Hold'em Tournament that DFS is sponsoring. It will be held at Royal Banquet Hall on November 5, 2005. 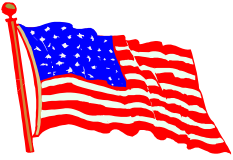

Don't Let Your Cats and Dogs Run at Large

Just a reminder that every owner of a dog and/or cat must contain their animal to the confines of the owner's real property unless the animal is under restraint. Also, the Village Code relating to dogs in the park states that all dogs must be on a leash of not more than six feet, may be exercised on all improved paths only (bikes paths or sidewalks), and that the person walking the dog must immediately remove all excrement from the premises. The failure of individuals to police their dog waste is a detriment to the park, and a hazard to its users. Thank you for your consideration.

RESIDENT REMINDER



Please remember that parking on the village streets is not permitted at all. If you are having a family function, party or gathering at your home you must contact Cen Com and notify them that there will be parking on the streets for that evening. Their number is 847-270-9111. They will need to know approximately how many cars will be parking on the street, your address and your guests will have to park on one side of the street. Cen Com will then notify the police department that there will be parking for the time given for your home so you could avoid getting a parking citation.
